ORDERING: For your protection as a consumer, and to ensure Floor Decor has all the correct information, all parties (homeowner, contractor and/or designer) are required to sign contracts and any paperwork involving design, selections and layouts. Material will be ordered once Floor Decor receives all required signatures.

PAYMENT, TERMS AND CREDIT EXTENSIONS: A deposit of 50% is required to place an order. Final payment for the order is due when the order arrives or when the material is installed, unless an open account has been established with Floor Decor.

LATE PAYMENT: If payment is not made according to terms of sale, purchaser agrees to pay interest at the lesser of 2% or \$5.00 minimum per month or the amount permitted by law and to pay reasonable collection costs including reasonable attorney fees.

FREIGHT CHARGES: our freight quotes are only an estimate and can, **and will be**, adjusted to reflect the actual freight cost. Additional freight costs will be incurred with order add-ons.

RETURNS AND CANCELLATIONS:

- Custom (special) orders NO RETURNS WILL BE ACCEPTED. These orders are non-cancellable.
- Additional returns are subject to vendor approval. Most vendors have a 30-day return policy that begins the day the material arrives in our warehouse.
- If a return is authorized by the vendor, there is a 25% restock fee plus return freight to the vendor.

QUANTITIES: Prior to ordering, Floor Decor requests that **all quantities be approved by an installer or contractor**, as we will not be responsible for discrepancies in quantities. Although we may have assisted in the preparation of quantities for material on this order / invoice, all quantities should be checked by a contractor or installer. Any additions or changes to the order can delay the delivery date, may result in dye lot variation and will result in additional shipping charges.

INSTALLATION BY OTHERS: Floor Decor does not accept responsibility, or liability, for installation, sealing, refinishing of any product not installed by Floor Decor. Please be sure to thoroughly discuss speciality and glass tile installation with your installer prior to installation. REFER TO THE MANUFACTURER'S INSTALLATION INSTRUCTIONS INCLUDED IN THE MATERIAL BOXES. Additional charges will apply if we supply installation.

UPON DELIVERY - Upon receipt of materials, please review the shipment for accuracy of quantity, quality, color and check for any shipping damage. Contact us immediately if problems exist. All claims must be in writing to Floor Decor and any delivery carrier within five working days of the original delivery.

RESIST SAMPLE FIXATION: A small sample of any material will always fall short of the beauty that you will see in your full order. Natural stone, dye lots and patterns will vary from lot to lot, as well as within the lot.

WHAT TO EXPECT DURING YOUR INSTALLATION PROCESS

Installers will move furniture, tear out and haul away your existing flooring if you have agreed to have these optional services performed. **Customer is responsible for moving antiques, china from china cabinets, removing books from bookcases, aquariums, safes, valuables, clothes, dishes, knick-knacks and family heirlooms. Installers can move electronic devices but will not be responsible for hooking them back up. Please strip all bedding, empty closet floors up to about 3 feet above the floor and remove items from under beds. IN THE EVENT OUR INSTALLERS HAVE TO PERFORM THESE TASKS, ADDITIONAL CHARGES OF \$65 PER HOUR WILL BE ASSESSED TO THE FINAL BILL.**
